3. Soil Investigation report to be conducted before preparation of scheme.
4. An elaborate structural analysis of the whole existing structure has to be done to check the stability for Construction of 70 MGD Jetty Mounted pump house over it.
5. 5 (Five) sets of complete DPR along with soft copy has to be submitted, incorporating the details of pump & Electro mechanical equipment which will be provided separately from electro mechanical end.
