- (2) Valid Income-Tax clearance certificates of last Three (3) years (for last 3 years in SARAL).
- (3) GST registration certificate.
- (4) Up to date professional Tax Challan.
- (5) Completion certificate/Payment Certificate showing execution of similar nature of job value not less than 30% of the estimate amount put to tender.
- (6) Registration certificate and / or Trade License of the company.
- (7) Partnership deed (in case of partnership firm) with written power of attorney of signatory of The deed.

Note: Failure of submission of any one of the above mentioned documents will render the tender liable to rejection.

Terms & conditions:

1. Supply of all labour, tools & tackles, instruments, equipment, accessories, as are needed to complete the job, in a manner as specified to the entire satisfaction of the E.I.C.
2. The contractor will be full responsible for safety and security of the labours, work men who will be involved at this work. Also, contractor will take care about surroundings areas and locality against any incident or accident during such work.

6. The Security period will be 3 (Three) months from the date of completion of the work.


