**EXECUTIVE ENGINEER, BPPD-II, E&AM SECTOR** for and on behalf of Kolkata Metropolitan Development Authority (KMDA) invites **ON LINE e-TENDER** in KMDA Form No: 1 from reliable, resourceful, bonafide, eligible firms/companies/individual/Joint Venture agencies who have successfully & satisfactorily completed the similar nature of works **in a single contract not less than 40% of the value of work put to tender or minimum 30% of the value of work put to tender in each of two separate contracts** within last **5(five) years** from the date of NIQ in any Government/Semi Government /Undertaking/Autonomous bodies/Local bodies.

**Scope of work :**

1. Construction of two or three standard size temporary type main entry/exit gates (gantry type) with floral decoration
2. Three side open (covered roof) stage with backdrop of approx 18'Lx 12'Bx 1.5'H and VIP chair & center tables & other chairs with carpet and floral decoration
3. Tentative fifteen covered selling stalls with required chairs and tables
4. Cloth fencing with bamboo,
5. Pandel of office lounge with required nos. of Sofa, VIP chairs and tables & other chairs with floor carpet
6. Raised covered wooden platform of cactii, succulent, orchid, bonsai etc with proper barricading.
7. Demarcation of different Class (at least 10) of plants with bamboo-rope fencing.
8. Tentative Cash prize money to the growers of rupees seventy thousands for different Sections. Payment has been made as per actual.
9. Tentative Conveyance allowance of growers and judges of rupees three lakh seventy thousands approx. Payment to be made as per actual.
10. Dinner @ Rs 150/- approx and breakfast/tiffin @Rs 80/- approx per packet of approx 80 growers/drivers.
11. Refreshment of Judges and other dignitaries @Rs 300/- approx per packet of approx 50.
12. Refreshment with good quality tea, biscuits, drinking water etc to the dignitaries and others throughout the show period to be provided by the bidder.

13. Two bio toilets with all facilities to be installed with proper maintenance staffs of each toilet over the period of five days (19<sup>th</sup> to 23<sup>rd</sup> January 2022).
14. Five labours including two skilled Mali for nourishing and watering of the plants should be provided by the bidder as well as sweeping of the premise etc of the program from 20<sup>th</sup> to 23<sup>rd</sup> January 2022.
15. Providing “Section Bamboo Sticks” of 1.5 feet height – 500 Nos.
16. Various types of stationeries, mementos, certificate, badges, uttoriyo, files, flower bouquet etc should be provided by the bidder.
17. Honourarium of Rupees fifty thousand for engaging the one horticulturist to guidance in arrangement of the flower show.

The above items/price may vary as per requirement of Show. Total sanctioned budgetary provision Rupees Twelve Lakh including GST and other statutory taxes.

2. Earnest Money will be deposited by the bidder through the following payment mode as per Finance Department Order No. 3975-F(Y) dated 28th July, 2016.

  - ii. RTGS/NEFT in case of offline payment through bank account in any bank.
3. Submission of Tender:- a) Pre-qualification/Technical Bid and Financial Bid both will have to be submitted online concurrently duly digitally signed in the website <https://wbtenders.gov.in> as per time schedule stated herein under. Time will be reckoned as per Server Clock. b) The Financial Bid of the Participant tenderers will be opened only if the tenderer qualifies in the Technical Bid evaluation.

Tenders will be opened by the **EXECUTIVE ENGINEER, BPPD-II, E&AM SECTOR, KMDA** or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

**5. Eligibility criteria for the bidders:-**

- a) The bidders should have the credentials of similar nature of works completed successfully & satisfactorily with the value not less than 40% of the estimated amount put to tender in a single contract or not less than 30% of the estimated amount put to tender in each of two separate tenders. Nature of works should be clearly mentioned.
- b) Scanned copy of valid up to date Professional Tax receipt Challan, GST as per latest Govt. order and PAN card issued by Income Tax Department, Valid Income tax (For last 3yrs), Credentials, Work Order, Payment certificate and other supporting documents, Registration Certificate and/or trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.

### **5.1 Declaration on Notary**

Scanned Copy of one affidavit before Notary will have to be submitted **mentioning the e-NIQ No.** and the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Autonomous body/Institution through on line at desired location.

**5.2** Partnership Firm/Consortium should submit necessary deed at desired location through on line.

### **5.3** Particulars regarding Joint Ventures/Consortium.

- i. The lead partner shall meet not less than 50% of the qualifying criteria mentioned above under any Govt./Semi-Govt. organization/Autonomous body as principal employer within last 5 (Five) years.
- ii. Whereas each of the other partners shall meet individually not less than 25% of the qualifying criteria mentioned above under any Govt./Semi-Govt. organization/Autonomous body as principal employer within last 5 (Five) years.
- iii. The lead partner shall have to apply for tender on behalf of Joint Ventures/Consortium along with MoA/MoU.
- iv. In case of any litigation or in the event of any default arises during the execution/contract period of the agreement, the lead partner will remain fully responsible.
- v. The successful Joint Ventures/Consortium will have to submit GST Registration. Pan Card, Trade License immediately after issuance of LOI.

**6.**

- a) **Earnest Money:-** The tenderer shall have to mention the reference detail in support of remitted RTGS/NEFT of requisite EMD against the tender in prescribed location failing which the tender shall be rejected. The balance earnest money if any to fulfill 2(two) percent of the tender value is to be deposited at the time of execution of formal agreement.
- b) **Additional Performance Security:-** On receiving of the bid, If it is found, the Tendered amount is 80% or Below of the Estimated amount, the L1 Bidder should have to deposit Additional Performance Security @ 10% of the Tendered amount in the form of Bank Guaranty in favour of KMDA for the entire contract period within 7(Seven) days from the date of issuance of LOI. The B.G will be returned immediately on successful completion of the contract.

- i) Copy of MoA/MoU on a stamp paper of Rs.100.00 outlining the joint interest to work on the project and specifying the other terms of agreement.

**8. Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English.

9. **Others:-** The Tender Notice along with other documents like Tender Form No.-1 KMDA, Technical Specification, Special Terms and Conditions, BOQ, Addendum and corrigendum etc. whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender.
10. **Declaration:-** Tenderer must upload and submit duly digitally signed a declaration as per prescribed format for confirmation of his awareness of the contract.
11. **Addenda/Corrigenda:** During the tenure of the tender if any addenda/corrigenda takes place that will be circulated only through the Government e-Procurement system.
