The application should be accompanied by duly attested photocopies of duly signed and endorsed following list of common documents by the applicant.

1) List of common documents :

- i) Valid Pan Card issued by the IT Deptt., Govt of India
- ii) Latest valid Trade License
- iii) Valid 15 digit Goods and Services tax payer Identification Number (GSTIN) under GST Act. 2017. And latest GST Return submitted copy
- iv) Latest Professional Tax paid Challan, latest P-TAX Enrolment & latest p-tax payment certificate.
- v) Credential in Similar nature of Work Order, Completion Certificate, Payment certificate, also supporting BOQ of the of the same work.
- vi) Latest Income Tax Return (For last 3 yrs)

The applicant shall also produce original of the above documents for verification during submission of the application failing which no permission for issuing of tender documents will be entertained.

2) Cost of Tender Paper :- Also the intending tenderer shall have to deposit cost of tender documents only in the shape of **Bank draft /pay order** drawn in favour of “**KMDA**” payable at **Kolkata** on a schedule Indian bank at Kolkata along with their individual application and relevant documents as stated above. **Cost of Tender documents is non-refundable for the Eligible Participants.** After Technical Evaluation Non- Eligible participant they may apply in the shape of application in their own letter head for refund of cost of Tender shape of Bank draft /pay order.

3) Earnest Money:-The tenderer shall have to deposit Earnest Money in the form of **Bank Draft/Pay order** drawn in favour of “**KMDA**” on a schedule bank payable in **Kolkata** failing which the tender shall be rejected. The balance **Earnest money** if any to fulfill **2 (two) percent of the tender value** is to be deposited at the time of execution of formal agreement.

5) Mode of Submission of Tender Documents :

Tenderer shall mentioned their offer rate **ABOVE or BELOW or AT PAR** of the departmental estimated amount put to tender in proper position of the documents both Tender Form and as well as last page of BOQ or Schedule both in figure and words written in indelible ink and in English language preferable.

6) Additional Performance Security:-

The Additional Performance Security @**10%** of the tendered amount shall be obtained from successful bidder, if the accepted bid value is **80% or less** of the estimate put to tender, **Additional Performance Security shall be equal to 10%** of the tendered amount and be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited. The said Bank Guarantee shall be valid upto the end of the Successful completion of the work and shall be renewed accordingly, if required. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the Contract period after serving proper notice to the contractor.

7) Penalty for suppression / distortion of facts: - If any document/statement/information submitted by any bidder in the tender is found to be false , TIA will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD).

8) Place of Purchase and Submission Tender Documents :-

- ii) “Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provision of GST Act 2017”
- iii) The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.
- iv) Earnest Money, Cost of tender paper and Formal Tender paper cost should be as a demand draft or bank pay order only and purchaser should be mention in the draft if any, deposited for one tender , it shall not be transferred to another tender.

v) Tenderer must be attached extra pan card Xerox/photo copy with the application as well as tender form no-1 for realising Accounts purpose

Vi) The successful tenderer shall comply with provision of contract labour (Regulation & Abolition) act, 1970 and the subsequent amendment thereof and produce the same before the authority.

Vii) Deduction of cess @ 1% at source will be applicable under section -3 of the Building & other construction worker's Welfare Cess Act,1996 read with rules 4&5 of the Building & other construction Worker's Welfare cess Rules,1998 and GST.

viii) Partnership Firm/Consortium should submit their necessary deed.

ix) A person/Proprietor, Partnership Firm/Consortium that is suspended / debarred by a procuring entity shall not be allowed to participate in this tender.


