5. Valid Electrical Contractor License.
6. Valid Electrical Supervisor competency.
7. Up to date Trade License certificate.
8. The firm shall have valid ESI & PF Registration.
9. A written declaration on letter head as to correctness of all documents submitted and a declaration of penalty/debarment etc. faced by them.

After scrutinizing all above documents department will issue tender documents if those documents are found in order.

In case of registered unemployed engineers' co-operative societies necessary registration paper in support of the registration shall be submitted.
