

 - iii) Date & Time of Purchase of Tender Form No.1 : 12.11.2021 Upto 2.00 P.M.
 - iv) Last Date of Receipt of Tender Form : 17.11.2021 Upto 2.00 P.M.
 - v) Date and Time of Opening of Tender : 17.11.2021 At 3.00 P.M.
 - vi) Application should contain with all documents including cost of tender documents in form of DD / Bank Draft of any Nationalized / Scheduled Bank in favour of "K.M.D.A." Payable at Kolkata". Application Money (cost of Tender Documents) is not refundable/adjustable for Successful & Unsuccessful applicants.

- 4 Photo copies of **Credential & Payment certificate for similar nature of work (single contract not less than 40% of the value of amount put to tender or minimum 30% of the value of work put to tender in each of two separate contracts), Trade License, Pan Card, GST Registration Certificate** along with **current quarter e-return, Professional Tax Document i.e Professional Tax Enrolment certificate with current year challan, Partnership Deed** (in case of partnership firm) with written power of attorney of the Signatory of the Deed, SARAL for 3(three) years must be submitted along with Application. Applicants should give written declaration in the form of AFFIDAVIT before NOTARY (ORIGINAL) as to correctness to all documents submitted by the applicant and a declaration of penalty/debarment etc. faced by him under any Govt./Autonomous Body/Institution etc. Applicants should mention Phone No./ E-mail contact of their employer (credential issuing authority) for verification of credentials if required.
