Tenders will be opened by the **Superintending Engineer, Circle-IV, HOUSINGSECTOR, KMDA** or his authorized representative in presence of tenderer or their authorized representatives who may like to be present.

6. Eligibility criteria for the bidders :-

a) Technical:-

- i. Intending tenderers should produce credentials of similar nature (as mentioned above Sl. No. 1, (a) or (b) of completed work in Single/Separate Tender together of the minimum value of Rs. 6.97Crore put to tender during 5(Five) years prior to the date of issue of the tender notice; or
- ii. Intending tenderers should produce credentials of one single running work of similar nature (as mentioned above Sl. No. 1,(a). or 1,(b) which has been completed to the extent of 70% or more and value of which is not less than the desired value at (i) above;

In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, Or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and-also that no penal action has been initiated against the executing agency, i.e., the tenderer. The credential for running work shall not be applicable for joint venture/consortium firm.

b) Financial:-

- i. The bidder should have minimum average annual turnover of Rs.6.97 (Six point nine seven) Crores during three consecutive financial year within last 5 (five) years ending on 31.03.2020. (Relevant documents shall be uploaded by the bidder through Tender Portal (www.wbtenders.gov.in)for checking the eligibility)
 - ii. Bank Solvency Certificate as per prescribed format (Annexure-III) minimum value of Rs3.48(Three point four eight) Crore or above and date of which shall not be more than 6 (six) months before the date of issue of the e-NIT.
- c) Scanned copy of original documents i.e. Valid PAN issued by the IT Deptt. , Govt. of India, Latest Professional Tax Paid Challan as per enrollment rate slab& P-TAX Enrollment Certificate, Valid income tax (For Last 3 yrs), Valid 15 digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017, Last 3 yrs Audit balance sheet ,Credentials (LOI/Work Order, &Completion Certificate of the same work as per Sl-1 & 6,(a) of this NIT),Employees PF and ESI , Bank Solvency Certificate as per Sl-6,b(ii), Valid trade license of the company must be submitted duly digitally signed at desired location in the website <https://wbtenders.gov.in>.
- d) The following clause shall be included in all the contracts to be executed for (i) procurement of goods and services and (b) works related contract involving supply of goods and services by contractor: “Tax invoice (s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017.”
- e) Scanned Copy of one original affidavit before Notary will have to be submitted mentioning the correctness of the documents and a declaration of penalty debarment etc. faced by him under any Govt./Semi-Govt./Govt. Undertaking /Autonomous body(constituted under the State/Central statute)/ Statutory Bodies and Local Bodies, submitted through online at desired location (as per Annexure-I) and declaration by the tenderer as per prescribed format (Annexure-II).
- f) Partnership Firm/Consortium should submit necessary deed at desired location through on line.
- g) Particulars regarding Joint Ventures/Consortium.
- i. One of the partners of any Joint Venture/ Consortium has to be designated as Lead partner and the same will be mentioned in MOA/MOU.
 - ii. The Lead partner must hold minimum 51% equity capital of the company to be formed between them during the tenure of contract implementation.
 - iii. The lead partner must have credential and satisfactory completion of the same nature of works of completion cost not less than 50% value of qualifying amount i.e. 10% of the credential value asked for present tender in a single contract under any Govt./Semi-Govt. organization/Autonomous body (constituted under the State/Central statute) as principal employer within last 5 (Five) years.
 - iv. Each of other partners shall meet individually not less than 25% of the qualifying criteria i.e. 5% of the credential value for present tender in a single contract under any Govt./Semi-Govt. organization/Autonomous body (constituted under the State/Central statute) as principal employer within last 5(Five) years.

- v. However the lead partner along with other partners/ partner should jointly meet at least 100% of the qualifying amount asked for.
- vi. The lead partner shall have to apply for tender on behalf of Joint Ventures/ Consortium along with MoA/MoU.
- vii. In case of any litigation or in the event of any default arises during the execution/contract period of the agreement, the lead partner will remain fully responsible.
- viii. The successful Joint Ventures/Consortium will have to submit GST Registration, Pan Card, Trade License immediately after issuance of LOI.

h) Earnest Money:-The initial Earnest Money shall be of **Rs.10,00,000/- (Rupees Ten Lakhs Only)**, shall be deposited through online as per the system in the tender portal i.e (www.wbtenders.gov.in) in the respective field, failing which the tender shall be rejected. **The successful tenderer shall have to be deposited an additional amount against Earnest Money @ 2% of the awarded tender value less 10.0 Lakh ,the balance amount shall have to be deposited in the form of Bank Guarantee issued by any Schedule Bank in favour of the “SUPERINTENDING ENGINEER, CIRCLE-IV, HOUSING SECTOR, KMDA” within 03(three) working days from the date of opening of Financial Bid.,** failing which the tender shall be rejected including forfeiture of EMD. EMD in the form of Bank Guarantee of successful Bidder shall have to extended upto the defect liability period or the equivalent amount of Bank Guarantee shall be deposited to KMDA in the form of Demand Draft which shall be converted as initial security deposit.

8. Time of completion: -Time of completion shall be 18(Eighteen Months) and 05 (Five) years O&M from the date of completion of the project and 03(Three) months

Trial Run for LTP which will be reckoned from the date of commissioning of the LTP.

9. **Provision of Defect Liability Period & Refund of Security Deposit :**

Prospective bidders shall have to execute the work in such a manner so that appropriate service level for the stipulated work is to be maintained during stipulated contractual period till completion and **Defect Liability Period for road work & Electromechanical Equipment & Machineries 05(Five) years and Defect Liability Period for other works is 01(One) year** and from the date of successful completion of the work. If any defect/damage is found during the period as mentioned above, the contractor shall make good the same at his own expense to the specification at par with instant project work, or in default, the Engineer-in-charge may cause the same to be made good by other agency and deduct the expense (for which the certificate of the Engineer-in-charge shall be final) from any sums that may be then, or at any time thereafter become due to contractor, or from his security deposit, or the proceeds of the sale thereof, or of sufficient portion thereof or from any pending dues for any contract with KMDA. Refund of Security Deposit will only be made after completion of **Defect Liability Period (DLP)**.

10. **Additional Performance Security:-**

The authenticated estimated amount put to tender is reserved with the **Tender Inviting Authority (TIA)**. The Additional Performance Security @10% of the tendered amount shall be obtained from successful bidder, if the accepted bid value is 80% or less of the estimate put to tender which is reserved with TIA, Additional Performance Security shall be equal to 10% of the tendered amount and be submitted in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptance, his earnest money will be forfeited. The said Bank Guarantee shall be valid upto the end of the Successful completion of the work and shall be renewed accordingly, if required. If the bidder fails to complete the work successfully, the Additional Performance Security shall be forfeited at any time during the pendency of the Contract period after serving proper notice to the contractor.

11. **Language of Tender:-** The tender shall be submitted in the prescribed form in English. All literatures and correspondence in connection with the tenders shall be in English. All illiterate documents shall be uploaded in English language only.

12. **Others :-** The Tender Notice along with other documents like **Tender Form No. - 1 KMDA, Technical Specification, Special Terms and Conditions , BOQ, Addendums and corrigendum's etc.** whatever documents uploaded by the department concerned thereto shall be part and parcel of the Tender. The agency must go through carefully the Special Terms and Conditions uploaded by the department before quoting his rate. **All the bidders are requested to upload only necessary documents for the tender. Uploading unnecessary/irrelevant documents may create problem in the evaluation process. In that case any inadvertent mistake during evaluation of the tender, Tender Inviting Authority (TIA) will not be responsible.**

13. **Penalty for suppression / distortion of facts:** If any document/statement/information submitted by any bidder in the tender is found to be false, the Tender Inviting Authority (TIA) will take legal action against the bidder including forfeiture of Earnest Money Deposit (EMD).”

14. **The tender inviting authority (TIA) reserves the right to accept or reject any or all the tenders without assigning any reason what so ever.**

15. **While evaluation, the committee may summon of the tenderers & seek clarification/information or additional documents or original in hard copy/soft copy, if any shortfall documents may required by the TIA it shall only be uploaded in Tender portal (www.wbtenders.gov.in) within the stipulated time period.**

16. **Any of the documents already submitted & if they are not produced within the stipulated time frame, their bid will liable for rejection.**
